

Corporate revenue decrease by 31% in June Quarter

Corporate revenues decreased by 31 per cent but profit margins decreased to 3.6 per cent in the June quarter. Domestic rating agency ICRA reported this by analysing the financial report of 489 companies which is at the conclusion.
